### Booking

When booking your bridal party, we will require a complete bridal contract with the following information.

- First & last names of each client
- Phone number for each client
- Service(s) and requested stylists
- A credit card that will be valid for the date of the wedding (will not be charged, just for security)

#### Cancellation Policy

We understand that life happens and things change, but if for any reason the date is canceled by the bride without at least 7 days prior notice, the credit card on file will be charged 50% of the total bill as agreed on by the bride and Accents Staff.

### Before the wedding:

We recommend that you make an appointment for a consultation and/or a trial with your stylist 1-2 weeks prior to the wedding. This will allow you the chance to communicate and plan your desired look before the big day.

At that time please bring any hair accessories or extensions you would like to use for the wedding. If you could also please bring with you a photo of your dress and a few potential hairstyles, that would be very helpful.

Just an FYI, if you plan on getting your hair colored or cut, it should be done 1-2 weeks before the wedding. Also any facial waxing should be done at least a week in advance.

### The day before:

For optimal results, please shampoo hair the day/night before. **DO NOT SHAMPOO THE MORNING OF WEDDING!** Please try not to use products or flat irons as this can affect how your hair will hold or curl the following day. This applies to all who are getting their hair done for the wedding.

### On the wedding day:

Please wear a zip up or button up shirt that does not go over your head.

We ask that the entire party that is getting their hair and/or make-up done arrive at the same time on time. If any member of the bridal party is late, the lost time could compromise the quality of the bridal party's complete look.

Pictures are a stylist's best friend when it comes to hairstyles. To make sure that you get the desired look you are going for, please bring a couple of pictures to give us an idea of what you like. The same can be true for make-up application as well.

To ensure that your services go smoothly, please share all of this information with your bridal party.
